Tokyo – July 28, 2022 – Advantest Corporation (Advantest) hereby announces Advantest resolved to acquire its own shares under paragraph 1, Article 459 of the Companies Act, at the Board of Directors meeting held on July 28, 2022 as follows.

1. Reason for acquisition of own shares

The target of the shareholder return that is in congruence with the second mid-term management plan for the three years starting from April 1, 2021 is to achieve a total annual return ratio of 50% or more, including share buybacks. As the revised earnings forecast announced today, operating cash flow is expected to increase steadily as the earnings are performing well. In consideration of the situation of cash on hand, we will acquire treasury stock for the purpose of shareholder returns, improving capital efficiency, and future restricted stock compensation plans.
