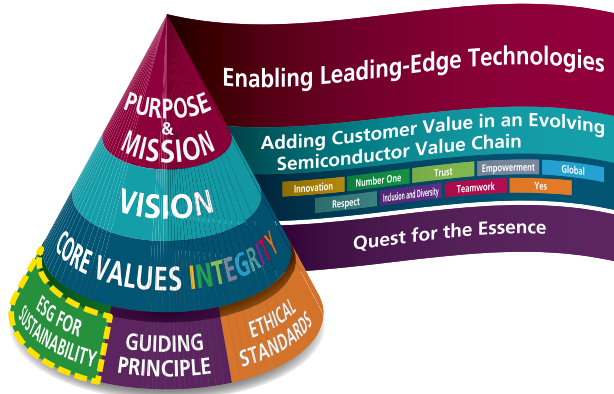


# ESG Summary

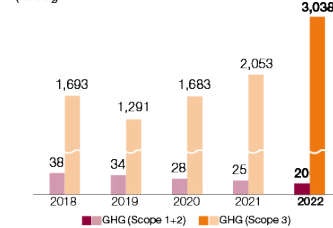

Targets : Achieve **carbon neutrality** by 2050



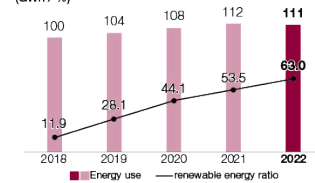
Reduce Scope 1+2 GHG emissions\* from business activities by **60%** by 2030 (vs. FY2018) \*Scope1+2
