2. Reasons for Determination of Interim Dividend Amount

Advantest makes dividend payouts based on semi-annual business performance with a target semi-annual payout ratio of 30%. Based on the consolidated financial result for the first half of fiscal year ending March 31, 2020 announced today, Advantest resolved to make the interim dividend of 41.00 yen per share.
